

Disclaimer: I was recently given KelpyG's Counter-Document that he made to this and I will do my best to provide my own updates to his claims below:

Hello everyone, Cookie here to address some recent allegations that have been being spread by a member known as KelpyG.

To explain the situation we must dive into the past. Back in 2020 (Before I was kurva staff) KelpyG, Techstar, and JudgeRed were three prominent members of the community. JudgeRed, at that time, was in his 20s, He was in a relationship with Techstar who was 17. And In the state of NYC where they reside, this is considered a legal relationship. While I personally disagree with it, the relationship was not my business, and I chose not to get involved. In early 2022 in my first few months as owner Judge_Red applies for discord moderator for Kurva and gets accepted by the members of staff processing around this same time KelpyG opens a report against Judge_Red stating that he was groomed by Judge_Red 2 years earlier while he was dating TechStar at this time note that all people involved are at the legal age of consent in their respective states. I was told by previous administration that Judge_Red already received a previous firing/Demotion for his relationship with TechStar due to the morality of the situation so when this report was made and the resolution requested was to fire red again members of investigations (Kurva's Private Democracy) it was determined that due to KelpyG not providing any hard-proof (screenshots) that the report was inconclusive and was already dealt with previously. Red eventually was removed from Kurva staff but remained inside of managements discord as a "Knowledge Archive" he did not have access to see all our management channels and had no access to vote on decisions made by management he existed only to answer questions about Kurva/Documents since all of kurvas management joined 2020-2021 including myself meaning documents, people and drama from the years 2018-2019 were very cloudy. In 2023 Kelpy learned of reds presence as an informant inside of management and felt lied to about a resolution being made. I informed him that this investigation concluded 2 years ago and we won't reopen this investigation unless there is something new to add. Kelpy then sent me a new document (2023) that contained actual hard-proof unlike his original document in 2022 that had no screenshots attached. With the removal of Oriimo in early 2023 (One of reds largest defenders) investigations had no "inconclusive" vote and instead voted for kurva to completely disassociate with Judge_Red which was met with Reds great protest in threatening to pursue legal action against myself for defamation and while it may be an empty threat you must know Judge_Red is a lawyer in NYC with much more money to toy around with then me who at this time is in heavy debt due to my father dying and having to pay out of pocket for all arrangements. (Relevant later) I desperately tried to find a middle ground resolution that would achieve what Kelpy wanted and not open me up to a defamation lawsuit; since their relationship was legal. Red finally agreed to disassociate with kurva on his own terms and decided to disappear.

Looking at the evidence kelpy provides against me being our chat conversation regarding his 2022 report I unfortunately was not the one “handling” that report as Oriimo was actively responding to this issue via my account given at that time she was leading “Investigations” and while I may have disagreed with Oriimo as some of you may know she had full control over my accounts during the years 2017-2023 from Bank accounts, social media, etc and I was rather “trapped” with agreeing with decisions she decided to make as kurva’s co owner at that time and while I have no evidence supporting this exact scenario due to the hijacking of my discord account in January 2023. I do have some other examples of her using my account to handle issues.

Now you may be asking why is all this relevant today? Recently KelpyG and I got into a civil disagreement regarding his bias inside of ban-appeals which led to him retiring. After his retirement he made it his mission to seek punishment upon me eventually leading him to reporting me to Northwood studios for “Not acting on his report” despite the actions I took during his reports. And Unfortunately due to Northwoods recent drama surrounding popular content creator Bako they have decided it best to cut ties with kurva to avoid getting dragged into public drama. I was reached out to by Northwood Representatives and was told I had 2 options “I could Leave the Official server program or leave kurva entirely” I was essentially being blackmailed by an ex-staff member due to them having a personal grudge against me. After a lot of back and forth talks I unfortunately could not retire/step down from my position due to having hosting contracts, partnerships and even a personal loan for the funeral I mentioned above leveraging my network as a financial asset. I made the hard decision to leave the official server program and unfortunately this resolution has not made KelpyG happy and he has decided to publicly try and “ruin” my reputation due to issues that happened before I was made kurva staff and that I felt I attempted to handle to the best of my ability when I finally gained control of kurva. I understand why kelpy feels the way he does about this situation and even now I harbor no resentment towards him and I wish him the best in trying to receive solace about what happened but I do hope he reads this and understands while I may have been the one messaging him it does not mean I was the bad guy in this picture and that it was not always up to me to make decisions given kurva has always run itself as trying to be a democracy and I do apologize for the system being rigged during his first report but there was nothing I could do against oriimos ideals or power. While I know we have had our disagreements and we don’t share ideals on rehabilitation I hold nothing against you and if you ever wish to have a civil discussion together my DM’s are always open if you unblock me, as I understand you only want justice for going through what you did. I wish you the best in life and to anyone reading this document if you wish to ask me questions my dms are open to all of you as well this issue is over 2 years old and barely within a few months of my ownership and I have grown a lot and cut ties with the negativity and controlling people I was around.

Some evidence below:

Kelpy Reopens his 2022 investigation with a new document providing screenshots after me commenting his original report was mainly text based with the one screenshot shown in his argument against me. .

The screenshot shows a Discord chat log with the following messages:

- Cookie** (08/16/2023 9:39 PM): You can think of me however you like and I understand if you want to not like me. A lot of people don't. I respect you and I appreciate your time into kurva and once again I wish I could of been there to help you get through that trauma. But I stand by my values I won't reopen the investigation 24 months later. And I'm sorry you disagree if you wish to reopen the case you can once again DM me screenshots and the evidence against red and I will reach out and re open but this will cause immense stress on both of you and I'd hate to see anyone relive those days
- Kelpy G** (08/16/2023 9:39 PM): there is nothing you can say or explain that is going to make me change my mind
I already made a document recently about it when asked for evidence to get him out of management
you may use that
idc if this causes him trouble, he deserves it for what hes caused to me for 3 years now
- Cookie** (08/16/2023 9:42 PM): I will reach out and regather evidence on it. This case has officially be reopened and I would recommend you grab any screenshots of examples of pedophilia as if I remember the document it was mainly text.
- Kelpy G** (08/16/2023 9:42 PM): the document i made the other week has screenshots at the bottom

Red "exiles" himself within 24 hours after the investigation's case is reopened.

The screenshot shows a Discord chat log with the following messages:

- Judge Red** (08/17/2023 5:00 PM): Finally I want to bring up that this is something that Kelpy's social circle has done for years now. They join places I'm in, accuse me of as much as they possibly can (usually exaggerated or outright falsified) and drag my name through the mud for their own amusement until I'm banned or shut out. I have dealt with this harassment for three years and haven't done anything I've been accused of in basically three years. It's been a while but people have approached me in real life, at parties, at work things, because of what these guys have done. I don't know the extant to which they're involved here, but I'd like to ask the question of when people say enough is enough. I understand that the conversation that took place three years ago was inappropriate. I've definitely paid for it in lost friends, harassment, and pain for myself and those around me. If you want elaboration on this I can provide.
I'd submit more proof of this if people need it but I'm not sure how to prove that a lot of these things don't exist.
- Judge Red** (08/17/2023 5:08 PM): Anyway, my advice would be this. Good luck to them and hopefully they're able to see what's going on here, and any misconceptions have been dissuaded. If they need anything else for proof let me know and I can revert.
- Judge Red** (08/17/2023 5:17 PM): I get that Kelpy will never leave me alone and he'll always target me with the past. I have a serious problem with being banned and labeled as a "offender" when my situation is entirely legal, but for your sake I will not message in Kurva ever again and I will leave on my own terms if you will allow that.

Some miscellaneous examples of Oriimo having access to my discord account was her responding to trouble spam pinging my discord account.

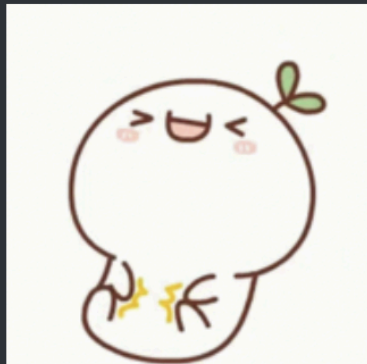

Update 1: A few responses to kelpy's new document.

I would like to point out a few instances inside of Kelpy's document that I flat out do not agree with. *'Cookie's actions of not only covering up a known pedophile but allowing him to keep an important role on staff as being used as an informant in management'* - This is simply not true. 'Covering up' and 'not publicly outing' are two different things. I am unsure how you see an informant as an 'important role'; it had no permissions and was used specifically if Kurva needed a document Red himself owned and we forgot to transfer. Or if issues pertaining to management/Kurva pre-2020 were discussed (Example: the Ban Appeal of CHerry & various Paradox members). And for the argument 'There were older members to choose from at that time', none were the previous assistant of Alby (the former owner) and owner of quite a few documents. I would also like to point out. Kurva removed Oriimo from power 08/14/23 the investigation was reopened 08/16/23 and Red agreed to exile 08/17/23 while it was not the "ban" you were looking for he still was blacklisted and removed within 24/hours of the reopening which I understand I did not inform you of and I apologize. (More on that below)

"He blames Mike and Ori for protecting Judge Red when Cookie himself sided with him" - You say this as if Oriimo and I did not spend over 19 hours a day on call, including while sleeping. Yes, 'I' did defend his actions due to it being within the age of consent; that does not mean the REAL person arguing that was Oriimo in our call as she read and practically responded to your messages, as you know she can and did read them.

"He has NEVER once mentioned these legal threats in either conversation we had" - Correct, as a resolution was still made after the threats were made and the legal threats were dropped. And as you say, *'A defamation case would go nowhere'*; like I mentioned above, it was not a chance I wanted to take against someone with much more funding than me.

"I was recently banned from Kurva, and previously Chaos Theory, due to Trouble's support of Cookie and word getting out." - Yes, you were banned for adding users with the sole intent to spread your document, which is against the rules for any drama. Your ban is appealable, as I said, I hold nothing against you for what you are doing.

"You have never ONCE mentioned that you didn't handle that original report" - You seem to not understand how toxic me and Oriimo's relationship was. She acted through me many times from DMing users, attending management meetings, creating documents. You name it, Oriimo has put my 'Owner' stamp on it; this was extremely escalated after me and Oriimo split up, with her still holding my accounts hostage. I only regained "Control" of kurva 08/14/23 after the deletion of our first discord.

"My 'bias' in a ban appeal. What actually occurred is TubbyMuffin repeatedly broke rules" - I received a report from TubbyMuffin saying "I think ban appeals has a grudge against me," to which I decided to try and look for his ban reason. Unfortunately, my Discord did not load, so I popped into Ban Appeals chat to see Kelpy saying "Tubby is the biggest degenerate sending furry porn etc. etc." (Note: I am going into this situation LOOKING for bias as IT WAS REPORTED). So I asked Kelpy, are these recent things or are you mentioning evidence from the 2020 era (when Kelpy and Tubby were staff)? After a back and forth discussion, I asked who took Tubby's appeal, and Kelpy took it. After further discussion, it was agreed all of Ban Appeals agreed with Kelpy's decision, and I dropped it at that.

I won't go into his evidence regarding Lion's screenshots as it's disrespectful to the company.

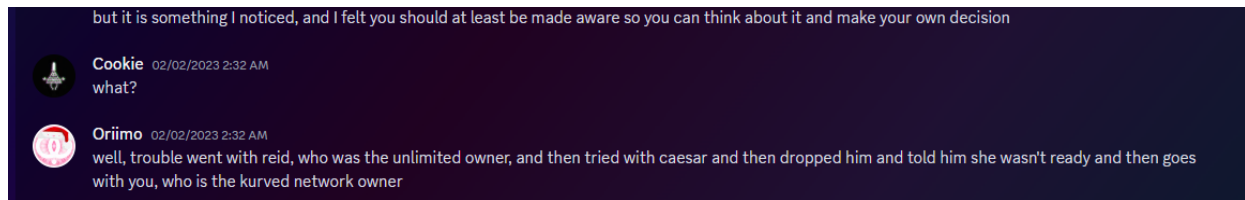
"You have continued to either keep me in the dark or just straight lie about the situation. These are YOUR choices." - I will say I do apologize for not informing you of the 'Exiled' decision or Red's threats of legal action. I hope people understand this was during the height of my LOA, as this was only months after my dad's passing, and I was extremely busy working 2 full-time jobs while helping my mother get through the process as well. Kurva was not my priority right then, and it just slipped my mind, given in my head the resolution was made. I do apologize for that, as that was my mistake.

"His two screenshots of Ori using his account mean nothing as, again, he has mentioned NOTHING to me about it before." - We are not friends. We have had maybe 3-4 conversations since your report in 2022, and mainly were Kurva-related things. I had no thought to randomly inform you of Oriimo's ideals about your situation. We did have a talk about you asking regarding my situation with Oriimo, and I believe we did briefly discuss the investigation. The quote you put is "Me and Oriimo agreed not to rehire him in any positions idk years ago we used him for old documents since Alby left," and this is completely true. But Oriimo did not want any punishment to fall upon Red, and it was only after a literal forever did she agree to blacklist him for the reason IIRC "He won't want to be staff anymore anyway." You have to know Oriimo's ideals of 'consent' being the age of 17+.

I also, for the record, want to point out Oriimo's opinion on 'Groomers/Pedophiles.' Some of you may remember Reid, the former owner of UnlimitedSCP, who was outed for grooming TtroubleTT. Oriimo's opinion on this situation was "Trouble got close to Reid for power; she was not groomed." I'll supply a screenshot below of Oriimo believing that Trouble is dating me for 'Power'."

Oriimo claiming that Trouble is with me for the same reason she went with reid because of "power". I also want to point out that her entire message is false. Caesar hit on trouble and she informed him that she wanted to remain friends. Months after her instance with Caesar, Me and

trouble began talking and Caesar got upset and left our friend-group and servers. .



Update 2: Regarding Kelpys' Responses to the above.

I truly don't have much to add, given that the majority of his response revolves around "You forgot about informing me," which I admitted previously that providing him with the resolution of the report slipped my mind due to my own issues. Another point brought up multiple times is the statement "I don't believe you," which I understand he won't believe me, and I genuinely don't think there is anything that could convince him otherwise.

He brings up my discussions on the age of consent. Yes, I do bring up the age of consent when it involves Red and Techstar because that is an important aspect for their situation. While Red and Tech may have "met up in real life to do things," they both lived as residents of the state of NYC where they were both within the legal age of consent. Additionally, despite being a member in Kurva, Techstar123 still has not filed a formal report against Red for their relationship to my knowledge. That does not mean I morally agreed with the situation, only that THEY were of the ages of consent.

You also mention that I "blame Oriimo." You seem to disregard the screenshot of me showing her ideals, saying "They are your ideals too." From the years 2017 to 2023, Oriimo and I "shared ideals" not by choice but by force; there was no room for disagreement with her viewpoints or desires. This is what is commonly referred to as a "toxic relationship" that I found myself stuck in, being manipulated. And while I did not inform you in 2023 when we talked after removing her that "She was the one to do your report XYZ," While against it at first due to the time-frame after thinking of Oriimos initial bias to your report I ended up giving you the choice to reopen the investigation as long as evidence was provided (which you did) and I began pressing Red regarding the issue. I was met with threats of legal action until he agreed to a compromise, and I went back to stressing about my actual real-life issues, forgetting about the encounter altogether due to how much was happening. Now, you may say "We talked afterwards," to which I will again say I completely forgot about Red's existence until your report to NW had me delve back into as much of the past as I could from this account, which resurfaced a lot of memories regarding the past and this situation.

This is a screenshot of my message activity with the ranges After: August 18 (day of drama) and

before my "Return" in January of 2024. You can see the jumps in my activity where I was simply just too busy to handle kurva things and I ended up forgetting about the Red issue altogether because of my own issues and for some reason in my head I just marked the issue as "Complete" and then went back to focusing on myself.
